Please note that DVDs over 2 plus hours will be in a more compressed file (not unlike the old HQ, SP, LP on the video tapes). If you have more than one shorter tape you wish to put on one DVD it is suggested you try this format first and if you are not happy with the quality it is suggested you put each tape onto its own separate DVD. MAXIMUM suggested length 4 hours.
CDs have a time limit of 80 minutes (WAV files). If you are prepared to have the files compressed to MP3 (as on an Ipod) then a number of tapes can go on one CD. These can however only be played on CD players that have MP3 features. Most modern players do have this facility but not older players.
